ITEMS FROM THE CITY ENGINEER

1. Carpenter Road Bridge Replacement, ST-993-Award

ORD-0043-2016 TO AUTHORIZE THE MAYOR TO ENTER INTO CONTRACT WITH SHELLY AND SANDS CONSTRUCTION FOR THE CARPENTER ROAD BRIDGE REPLACEMENT ST 993.

> Priestas said bids were open Friday April 15; Shelly and Sands was the lowest bidder; over 451K; request an ordinance to enter into contract with Shelly and Sands; McGregor asked when this will start; Priestas said mid-June and complete by mid-August.

2. Assessment 297 West Johnstown Road

<u>SR-0001-2016</u> TO DECLARE THE NECESSITY AND INTENT TO APPROPRIATE CERTAIN REAL ESTATE AT 297 WEST JOHNSTOWN ROAD FOR SANITARY SEWER SERVICES.

> Priestas said this is a necessity and intent for 297 West Johnstown Road; has a failing septic system; they have been issued notice by Franklin County; they have financial challenges; we are requesting Council adopt a Statutory Resolution; McGregor asked how many

properties there are; if there are contiguous properties still on septic; Priestas said will have to verify that information; McGregor asked if there is a benefit of doing more than one at a time; Priestas said we could but this is specific to the property owner and their notice from the Franklin County Board of Health; Schnetzer said this will stay with the property; Bury said from proprietary fund to the sanitary sewer fund.

ITEM FROM THE DIRECTOR OF PUBLIC SERVICE

1. Replacement of 2 1/2 Ton Truck- Unit #793

ORD-0044-2016 AUTHORIZE THE MAYOR TO ENTER INTO PURCHASE TO Α AGREEMENT WITH COLUMBUS PETERBILT FOR THE REPLACEMENT OF A 2 1/2 TON TRUCK (UNIT # 793), CHASSIS AND SNOW PLOW; OHIO STATE CONTRACT #800261-STS515.

Franey said we have a 2.5 ton truck that needs replaced; it is on the state contract; we want to split up the purchase; because they are on state contract we do not need to formally bid or need a waiver of a bid; need legislation to allow for the purchase; need two pieces of legislation; funds are from the equipment replacement fund; mostly from streets and some from general fund dollars; Leeseberg asked if they have assembly required; Franey said believes they come fully assembled; Larick asked for the vehicle rating sheet; Franey said she will get that to him.
