## **ACTION ITEMS FROM THE CITY ENGINEER**

## <u>ACTION ITEM # 1 –Whitley Drive Storm Sewer Easements – Accept Deeds</u>:

Two easements were necessary for the installation and construction of a minor storm sewer extension at 490 and 498 Whitley Drive to alleviate drainage issues for several residents in this area. The necessary easements were granted by the property owners and have been recorded and are ready for acceptance.

We are respectfully requesting two ordinance's to accept both deeds of easement. (Deeds and RCA attached.)

ACTION ITEM # 2 —Park Crossing/The Parc - Sanitary Sewer Easement SA 1022—471 North Hamilton Road -Accept Deed: Park Crossing/The Parc is a multi-family development located at 471 North Hamilton Road that is near completion. The construction of the development required the installation of a sanitary sewer. A sanitary sewer easement was necessary for the installation and construction of the sanitary sewer extension. The necessary easements have been granted by the property owner and have been recorded and are ready for acceptance.

We are respectfully requesting an ordinance to accept the deed of easement. (Deed and RCA attached.)

ACTION ITEM # 3- Park Crossing/The Parc – Sanitary Sewer Infrastructure SA 1022 - 471 North Hamilton Road – Accept Infrastructure: Park Crossing/The Parc is a multi-family development located at 471 North Hamilton Road that is near completion. The construction of the development required the installation of a sanitary sewer. The developer has requested that the sanitary sewer be accepted. The sewer meets the basic requirements for acceptance in that the underground utility has passed all necessary inspections and testing. Attached are the developer's request for acceptance, a diagram of the sanitary sewer and the letter of completion.

We are respectfully requesting an ordinance to accept the Park Crossing/The Parc Sanitary Sewer infrastructure. (Related documents and RCA attached.)

## **UPDATES**

Big Walnut Trail Section 4 Public Open House – The Department of Public Service and Engineering will be holding a public open house on Tuesday, May 30, 2017 from 5 to 7pm at the Sonybrook United Methodist Churck, located at 485 Cherry Bottom Road, Gahanna, OH 43230, to obtain input and feedback on the proposed trail project and alignment.

Hamilton Rd Central – Over the next couple of weeks, crews will have temporary lane shifts throughout the project as they work to finish street lights, sidewalk, curb ramps, and driveways, as well as the multi-use trail on the west side of Hamilton Road. If time and weather permit, the contractor is expecting to begin the process of installing top soil in the island areas in preparation for the installation of sod. All final restoration and surface asphalt will be completed late Spring/early Summer of 2017.

Motorists should continue to expect delays throughout the construction zone, and are encouraged to consider other routes if they wish to avoid a possible delay in their travels.
