ACTION ITEM # 1 – Larry Lane Bridge Replacement ST-1050 & Pizzurro Park Bridge Replacement ST-1042 – Award Contract: The bridges that carry Larry Lane over Sycamore Run and Pizzurro Park Drive over an unnamed tributary of Big Walnut Creek are currently rated in poor condition and are in need of replacement.

On March 16, 2018, bids were opened and reviewed. The lowest responsive and responsible bidder was Law General Contracting with a bid price of \$508,627 to perform the work which was below the Engineer's Estimate of \$515,960.50. We are requesting a 10% contingency to cover any unforeseen construction costs. (see attached for Contract Documents and Bid Summary)
