#### E. APPLICATIONS - PUBLIC COMMENT

City of Gahanna

CC-0001-2018

To recommend to Council, changes to Part Eleven - Planning and Zoning Code, Chapter 1150, Olde Gahanna District, Sections 1150.05(a) Permitted Uses and 1150.05(b) Conditional Uses, of the Codified Ordinances of the City of Gahanna.

(Advertised in the RFE on 4/5/2018)

Blackford showed zoning map for Olde Gahanna (OG-2); only changes tonight impact that colored area; proposing change because of requests for uses in OG-2; this was trying to fix some of the code related issues with uses; the redline version is provided to the Commission; requesting to add to permissible uses and one conditional use; overnight boarding for animals is currently permissible but would make it conditional; we are slowly going through Zoning Code update; how we categorize uses will be something we look at but this request should not wait; this is a recommendation to Council; Suriano asked about musical groups and if it is temporary now; Blackford said does not believe there is any permitting right now; has been successful in that area; Keehner asked about other artists; Blackford said the definition and clarity; limited by music and artists; others may be in other sections of code; Burba said in late 1990s, early 2000s, City passed code change allowing churches in only certain districts; why exception for this district; that was all taken care of; Blackford said our code allows for churches in that zoning and other zonings; are religious organizations now in OG-2; believe changing the code to allow religious organizations will not have a detrimental effect; will not create a lot of new church developments in that area; Burba expressed concern with overnight boarding; Blackford said this makes them more restrictive; would like to at least make it a conditional use vs. allowed by right; Hicks asked why not exclude; Blackford said has to do with the code number; it has to do with about 15 other uses; not sure if we want to prohibit them all or not; do we want to allow a doggie daycare; to change this would require re-advertising; Suriano said the way it is, we would still see the application; Hicks said the public has taken parcel; this code change relates to that parcel; are there pending inquires; Blackford said no; Keehner said clarified the allowable uses regarding pets; Blackford said can add more permitted uses to conditional uses; Wester said in last year, Westerville has been dealing with massage parlors, where do they fall; are they excluded; Blackford looked in the codes; said we use different references in our code; not simple; is permitted right now; a lot of this discussion is because of the way uses are coded throughout code; will look at these as we rewrite the zoning code; Keehner said this is discussing Olde Gahanna right now.

A motion was made by Keehner, seconded by Hicks, that the Code Change be Recommended to Council for Approval.

Discussion on the motion: Wester said want to protect City and residents; staff did a good job.
