## ACTION ITEM #2 - Road Salt (2018-2019- Winter Season) - Award

**<u>Contract</u>**: Southwest Ohio Purchasers for Government (SWOP4G) invites members of the organization (local governments and political subdivisions) to partner with them for the cooperative purchase of road salt each winter season. As members, the City of Gahanna is eligible to participate in this program. On June 18, 2018,

bids for road salt for the 2018-2019 winter season were opened and reviewed. The lowest responsive and responsible bidder for Gahanna's salt needs is Cargill, 24950 Country Club Blvd, Suite 450, North Olmsted, OH, 44070. The bid price is \$82.72/ton plus an \$8.00/ton piling charge. The following chart shows the rock salt cost history:

## UPDATES

**Tree Planting Initiative/Survey** –The City of Gahanna, Franklin County Soil and Water Conservation District, and the Ohio State University are partnering to complete door to door surveys of residents between July 9<sup>th</sup> and July 20<sup>th</sup> in an effort to obtain data from residents to understand what might help them take the initiative and next steps to plant trees on their private property. The Surveys will be conducted in the Academy Woods, Academy Acres, Cherry Bottom Gardens, Cherrywood Place, and the Crossing at McKenna Creek Subdivisions. **Larry Lane Bridge Replacement –** Law General Contracting will be performing the work associated with the Larry Lane Bridge Replacement project. This project will remove and replace the bridge that carries Larry Lane over Sycamore Run which is located on Larry Lane between Anthony Court and Lyncroft Drive. The project is scheduled to begin Monday, July 9, 2018 and is expected to be completed by Friday, August 17, 2018 (weather permitting). Larry Lane will be closed to through traffic for the duration of the project. A signed detour route will be provided that will direct motorists south on Lyncroft Drive from Larry Lane, to Heil Drive west to Mill Street/East Johnstown Road, and then north back to Larry Lane. Traffic heading east at Heil Drive will be directed to Worman Drive, then east to North Hamilton Road. The same detour route will be provided in reverse order from the intersection of Larry Lane and East Johnstown Road.
