# ACTION ITEM #1 - Fleet Program Auction Proceeds Supplemental

<u>Appropriation</u>: When we created our current fleet program, we tried to design it to encourage efficient behaviors and discourage waste. One specific issue that had plagued us was what we refer to as "fleet creep." One negative to fleet creep is when departments acquire equipment that requires regular preventive maintenance even though it is not often used and should actually be rented when needed.

In an effort to encourage each department to "right-size" their fleet, the fleet program includes the caveat that the proceeds from the sale of equipment would be held for future equipment purchases by the department that sold the equipment. For this piece of the program to work, Council action is required to supplementally appropriate the money from the sale of equipment to the proper expense line items so that the funds can be encumbered and spent on future equipment. We have begun performing this action on a quarterly basis. We are currently bringing forward the auction proceeds from 2<sup>nd</sup> quarter 2018.

### ACTION ITEM #2- Insurance Claim Proceeds Supplemental Appropriation:

When damage occurs to City property (vehicle, streetlight, fire hydrant, etc) the repairs are paid out of our current appropriations. Our appropriations are tight and do not necessarily have enough money to cover damage from unforeseen accidents. When we receive the insurance payments, we ultimately want those funds to end up in the expense accounts that paid for the repairs. We have begun performing this action on a quarterly basis. We are currently bringing forward the insurance claims proceeds from 2<sup>nd</sup> quarter 2018.

# <u>ACTION ITEM #4 – Central Park TIF Streetlight Supplemental</u>

Appropriation: The intersection of Techcenter Dr and Science Blvd currently has 7

streetlight bases that were installed for future lighting needs as the corridor developed. With increased pedestrian and vehicle traffic from new development, we would like to complete this streetlight system to ensure public safety. The streetlights are located within the Central Park TIF District and as a result the Central Park TIF may pay for the cost of the streetlights.

Council action is required to supplementally appropriate the money from the unappropriated/unencumbered balance of the Central Park TIF Fund to the Central Park TIF streetlights expense line item so that the funds can be encumbered and spent on the equipment.
