ACTION ITEM #1 – Snow and Ice Removal Services (2018-2019 Winter Season): In the past, the City of Gahanna has plowed approximately 10 lane

<u>Season</u>): In the past, the City of Gahanna has plowed approximately 10 lane miles of Columbus streets each year. The City of Columbus pays a contracted rate to Gahanna for each lane mile. The current rate is \$760 per lane mile each year for these services.

We are respectfully requesting legislation authorizing the Mayor to enter into contract with the City of Columbus for snow and ice removal services for the 2018-2019 winter season (service agreement attached).

City Service Expo/Touch-A-Truck Event — The City of Gahanna's Department of Public Service and Engineering is excited to announce the return of the Service Expo/Touch-A-Truck event on Saturday, August 25, 2018 at Hannah Park, 6547 Clark State Road, from 9:00am until 1:00pm. This event provides a great opportunity for the whole family to see, touch and sit on the big equipment that makes Gahanna run. Visitors will have a chance to get up close to a backhoe, bucket truck, tractor, fire truck, police cars, snow plow and garbage truck, just to name a few.
