## ADDENDUM TO EXTEND THE AGREEMENT FOR AN ADDITIONAL PERIOD

This Addendum to Extend the Agreement for an Additional Period ("Addendum") shall be attached to and made a part of the Service Agreement for Administration of a Claims Program that was effective March 1, 2011 between City of Gahanna ("Client") and Sedgwick Claims Management Services, Inc. ("Sedgwick") (the "Agreement").

In consideration of the Agreement recitals and the mutual covenant and conditions contained herein, the Parties acknowledge that the Agreement is hereby amended as follows:

- 1. The Agreement shall be extended for an additional period commencing January 1, 2019 and ending December 31, 2021.
- 2. Client shall pay Sedgwick the following fees on a life of contract basis for services provided during this additional period:

## A. <u>Claims Administration Fees:</u>

i. January 1, 2019 and ending December 31, 2019:

Self-Insured WC Flat Fee: \$12,798. State Fund Flat Fee: \$1,000.

ii. January 1, 2020 and ending December 31, 2020:

Self-Insured WC Flat Fee: \$13,054. State Fund Flat Fee: \$700.

iii. January 1, 2021 and ending December 31, 2021:

Self-Insured WC Flat Fee: \$13,315. State Fund Flat Fee: \$400.

## B. Miscellaneous Charges:

- i. January 1, 2019 and ending December 31, 2019:
  - a. viaOne access, which includes two (2) view users and one (1) query user, is included in the claims administration fee. Additional access is available for a fee of \$321 per view user per year and \$1,607 per query user per year.
- ii. January 1, 2020 and ending December 31, 2020:
  - a. viaOne access, which includes two (2) view users and one (1) query user, is included in the claims administration fee. Additional access is available for a fee of \$327 per view user per year and \$1,639 per query user per year.

- iii. January 1, 2021 and ending December 31, 2021:
  - a. viaOne access, which includes two (2) view users and one (1) query user, is included in the claims administration fee. Additional access is available for a fee of \$334 per view user per year and \$1,672 per query user per year.

  - i. Deposit the recovery funds and issue payment from Sedgwick's accounts Payable system to Client for the net recovery (less Sedgwick's fee). Sedgwick will deposit the net recovery check into the Client's loss-funding account or forward it directly to the Client.
  - ii. Deposit the recovery funds into the Client's loss-funding account and Sedgwick shall receive payment from the claim file or directly from Client.
