Medication Assisted Treatment

Access Ohio's MAT Program starts at 5 days per week and includes 9 required hours of treatment activities:


- Group (7.5 hours per week)
- Individual Counseling (1 our per week)
- Weekly appointment with prescribing physician
- Daily dosing appointments with nurse
- Unlimited strengths-based case management

As clean time and recovery skills increase the number of days and required number of treatment hours will decrease.

Services offered Monday - Saturday

The More You Know

- Ohio Medicaid is required for treatment at Access Ohio.
- It is not necessary to stop using prior to coming to treatment.
- If individuals want to detox and/or reduce their amount of use before starting treatment they can, yet it is not required that they do so.
- All of our treatment programs are abstinence-based which means once treatment starts all AOD use must stop.
- At Access Ohio we believe there is a difference between actively using and relapse.
- We understand that relapse is a part of recovery and will help individuals develop their own specific plans to avoid (or limit) access to specific people, places, things and situations that trigger use.
