ACTION ITEM #1: SUPPLEMENTAL APPROPRIATIONS - DAMAGE TO CITY PROPERTY

The Department of Public Service and Engineering has received funds from the damage of City property. We are respectfully requesting an ordinance for supplemental appropriations in the amounts itemized below from the unappropriated/unencumbered balance of the various funds to the respective accounts:

General Fund 1010 to 1011.1400.5220 (Maintenance Services) in the amount of \$2,422 General Fund 1010 to 1011.1420.5306 (Fleet Services) in the amount of \$5,236 Streets Fund 2200 to 2201.1000.5300 (Materials and Supplies) in the amount of \$153 Water Fund 6510 to 6511.1000.5300 (Materials and Supplies) in the amount of \$1,819

ACTION ITEM #2: SUPPLEMENTAL APPROPRIATIONS - WATER METER FEES

The Department of Public Service and Engineering has received funds from water meter fees. We are respectfully requesting an ordinance for a supplemental appropriation from the unappropriated/unencumbered balance of the Water Fund 6511 to 6511.1000.5300 (Materials and Supplies) in the amount of \$18,062.

ACTION ITEM #3: ROAD SALT CONTRACT (2019-2020 WINTER SEASON)

Southwest Ohio Purchasers for Government (SWOP4G) invites members of the organization (local governments and political subdivisions) to partner with them for the cooperative purchase of road salt each winter season. As members, the City of Gahanna is eligible to participate in this program. On June 25, 2019, bids for road salt for the 2019-2020 winter season were opened and reviewed. The lowest and best bidder for Gahanna's salt needs is Cargill. The bid price is \$82.72/ton plus a \$10.00/ton piling charge.

We are respectfully requesting legislation authorizing the Mayor to enter into contract with Cargill for road salt for the 2019-2020 winter season. There are currently sufficient funds appropriated in the 2019 budget to pay for this contract.

ACTION ITEM #6: REVISION TO PART THIRTEEN – BUILDING CODE OF GAHANNA CODIFIED ORDINANCES

We are respectfully requesting legislation modifying PART THIRTEEN – BUILDING CODE to accommodate the current edition of the Residential Code of Ohio. The local Climatic and Geographic Design Criteria table needs to be updated, including the design wind speed, updated flood hazard maps, and where calculations are required to be submitted for HVAC systems. This table is required to be completed by each jurisdiction that adopts the residential code, and the table was amended for the current code. Please refer to the attached revisions for the table which show the existing table and the revised table of the Residential Code of Ohio.

ACTION ITEM #7: REVISION TO BUILDING AND ZONING FEE SCHEDULE

The Building and Zoning Fee Schedule needs to be amended to include the values for escrow amounts for driveways and sidewalks. These are the amounts that contractors are required to set aside for the construction of driveways and sidewalks if not completed at the time of the project completion, usually due to climatic conditions. These fees were previously in the schedule, but had been omitted when the schedule was updated. We respectfully request that these fees be restored to the schedule. Also, we are proposing to amend the fee type for Minor Limited Scope of HVAC alterations by adding the fee for Walk-in Coolers and Freezers into this category. This will help clarify that those units can be classified a minor limited scope work. We are respectfully requesting that this revision be included for the Walk-in Coolers and Freezers.
