ADDENDUM TO EXISTING CONTRACT FOR GAHANNA, OHIO

We value the relationship with Gahanna and appreciate every opportunity to be of service to you and your citizens. We have included an addendum to include the following additional services to the republication and supplementation project for the City of Gahanna. All additional pricing will remain the same as outlined in the contract.

After each Legislative session, a Municode attorney will review the Traffic (Title XLV) and Criminal (Title XXIX) portions of the Ohio Revised Code (ORC) for revisions, deletions, or additions to these titles. Our attorney will determine which sections of the city's Traffic and Offenses chapters are affected by these legislative changes, and will prepare ordinances to conform to the updated legislative language. The City Attorney can then easily review the recommended changes to be adopted by the ordinances. Once these ordinances are adopted, the City will need to send the ordinances back to Municode and the changes will be incorporated into the code with the next scheduled supplement. Each history note in the code will cite the ORC section and the ordinance number as adopted by the City.
