HEIL DRIVE BRIDGE ST-1047 - RENEW PROPERTY ACQUISITION

The temporary easements that were authorized by ORD-0026-2019 (Report to Council 02/11/2019) for the Heil Drive Bridge Replacement will expire on March 4, 2020. To assure completion of weather dependent work, the temporary easements will need to be renewed. We are respectfully requesting authorization to enter into a real estate purchase agreement, to sign all documents to acquire the property, and accept the deed for the property acquisitions needed for the Heil Drive Bridge replacement.

We are respectfully requesting legislation to enter into contracts with these three property owners for the necessary easement acquisition. Emergency and waiver is being requested to complete the required paperwork prior to the March 4, 2020 expiration date. Future legislation will be needed for the acceptance of the easements. REYNOLDSBURG-NEW ALBANY ROAD AND CLARK STATE ROAD IMPROVEMENT - COOPERATIVE AGREEMENT BETWEEN FRANKLIN COUNTY AND CITY OF GAHANNA

Franklin County will be undertaking construction of a roundabout at the intersection of Reynoldsburg-New Albany Road and Clark State Road, in Jefferson Township. Franklin County is the lead agency. The City of Gahanna requires a new water main and other miscellaneous maintenance improvements to be constructed at that intersection. The attached agreement states that we will pay the County for the removal and replacement of our waterline as part of the intersection improvement including a third party inspection for the project.

We are respectfully requesting an ordinance authorizing the Mayor to sign the cooperative agreement and a supplemental appropriation to place the funds in the Water Capital Maintenance account.

FIBER RESTORATION AND MAINTENANCE – RENEWAL AMENDMENT

Columbus Fibernet (CFN) is a subsidiary of Fishel that currently provides maintenance and management of the City's fiber optic network. The service agreement with CFN expires 03-19-20. The fiber committee and CFN have mutually agreed to renew the service agreement. The term of the renewal is for three (3) years, commencing March 20, 2020 and ending March 19, 2023, with the provision for two (2) separate extensions of one (1) year each. The cost (including the annual retainage fee) is \$30,500 per year for the initial term of the renewal (year 1-3) and \$31,400 per year for each extension.

We are respectfully requesting legislation authorizing the Mayor and the Director of Public Service and Engineering to enter into the renewal amendment with Columbus Fibernet. Sufficient funds have already been budgeted in the 2020 appropriations to cover this renewal.

FIBER USE – LEASE AGREEMENT

Zayo Group desires to lease the right to use twelve (12) fibers from Gahanna along two (2) separate routes. The term of the lease is for one (1) year with the provision for separate renewals of one (1) month each thereafter. The fibers and system will remain the sole property of the City; however, the 12 fibers will be dedicated to Zayo Group's sole and exclusive use. In lieu of paying an annual lease fee for the initial term, compensation will be in the form of conduit installation totaling 19,660 feet. The City will retain ownership of the conduit upon its acceptance. If the lease is renewed, Zayo Group will pay a fee of \$10,000 per month through the renewal term.

We are respectfully requesting legislation authorizing the Mayor and the Director of Public Service and Engineering to enter into a lease agreement with Zayo Group for fiber use.
