AUCTION SERVICES – EXTENSION ADDENDUM

IronPlanet (dba GovPlanet) is the company that currently provides auction services through the Sourcewell (formerly National Joint Powers Alliance, NJPA) cooperative purchasing contract. IronPlanet specializes in auction services that help government agencies achieve faster sales and generate higher returns. The current contract expires in June 2020; however, Sourcewell elected to extend the contract for another year until June 2021. The department has been extremely satisfied with the services provided and the revenue generated and therefore would like to partake in the extension. In order to do so, an addendum must be signed by both parties.

We are respectfully requesting legislation authorizing the Mayor and the Director of Public Service and Engineering to enter into the extension addendum with IronPlanet (dba GovPlanet) for auction services.
