# Mayor

Mayor Jadwin congratulated Sergeant Sheasby on his promotion and thanked the Wolf Den pack St. Matthews 3317. She shared updates of hiring a Marketing Manager who will start on March 23, Mary Szymkowiak. A follow up to EV charging stations, Mr. Crawford is currently reaching out to other communities and will provide more detail in future meetings.
