**ACTION ITEM # 1 – Amendment Request §529.07 GCO Open Container:**

The Division of Police respectfully requests Council amend §529.07 [Open Container] of the Gahanna Codified Ordinances (GCO) for the purpose of establishing exceptions within existing code for possessing an opened container containing an alcoholic beverage within a Designated Outdoor Refreshment Area (DORA) created pursuant to §4301.82 of the Ohio Revised Code – See Attachment A.

By passing the amendments requested, the enforceability of the code is not impacted should a DORA not be sought or granted within the City of Gahanna.

As the process for updating the GCO for compliance with the Ohio Revised Code is underway, the Division would request passage in advance of the implementation of a DORA in order for the requested changes to be a part of the next update from the City's codifier.
