(B) An executed copy of the Columbus Regional Energy Special Improvement District Program Plan Supplement to Plan for 817 N. Hamilton Road, Gahanna, Ohio Project (the "Supplemental Plan");

(C) A substantially final form of the Special Assessment Agreement, by and between the County Treasurer of Franklin County, Ohio, the City, the Columbus Regional Energy Special Improvement District, Inc. (the "District"), the Owner, and Greenworks Lending LLC (the "Investor"); and

(D) A substantially final form of the Energy Project Cooperative Agreement, by and between the City, the District, the Owner, and the Investor.

4. With respect to the proceedings pertaining to the passage of Resolution RES-024-2020 and the adoption of Ordinances ORD-099-2020 and ORD-100-2020:

(A) All meetings of the City Council, and of its committees and any other public bodies, at which the formal actions were taken, or at which deliberations that resulted in such formal actions were held, were open meetings, and such formal actions were taken and any such deliberations took place while such meetings were open to the public, in compliance with all legal requirements, including Ohio Revised Code Section 121.22.
