Discussion:

Mr. Schnetzer thanked the Mayor, Staff and Councilmembers for their hard work. He thinks the budget presents balance. The Capital Maintenance Program is fully funded and additional funding for a sidewalk maintenance program. He called out an NLC survey that showed that many communities were cutting back on capital expenditures and infrastructure projects. Gahanna does not find itself in a similar position which is remarkable. He supports this ordinance.

Ms. Bowers thanked Mr. Schnetzer for facilitating productive and organized budget discussions over the last several weeks. She is thankful that the capital improvements are funded and hopes to keep focus on ensuring that appropriations support the city and citizens that live here. She passed along a request for the projections from RITA by the administration.

Mrs. Angelou thanked the administration and Mr. Schnetzer for leading the charge and hopefully there will be a better year next year.

Mr. Larick thanked the Administration, Mayor and Mr. Schnetzer for working through the budget and making the necessary adjustments. The discussions would have been difficult had there not been CARES funds.
