<u>ACTION ITEM # 1 – ORDINANCE TO ADOPT AMENDMENTS TO GAHANNA CODE CHAPTER</u> 913-LANSDSCAPING REQUIREMENTS

Related to the proposed Sidewalk Maintenance Program, the Administration is respectfully requesting legislation to amend Chapter 913 of Gahanna Code to add specific references to sidewalks and multi-use paths in order to clarify instances of when and how the City may take action to address street trees. <u>ACTION ITEM #2 – REQUEST AUTHORIZATION TO ENTER INTO CONTRACT FOR SPLASH PAD</u> CONSTRUCTION

In the 2021 Capital Needs Assesment, City Council approved funds for the installation of a new splash pad to be located at the Gahanna Swimming Pool. The addition of the splash pad will provide a much-needed improvement to the amenities available to our community. The features of the splash pad will allow movement and encourage imaginative play appropriate for a wide range of children of all abilities. The Vortex play equipment was approved by Council and purchased through the Sourcewell cooperative purchasing agreement. The construction of the splash bad was competitively bid.



We are respectfully requesting legislation authorizing the Mayor to enter into a contract with Astro Pool Company, in an amount not to exceed \$291,053, for the construction of the splash pad at the Gahanna Swimming Pool. Respectfully, a \$16,000 supplemental appropriation is also being requested due to the inflation of construction and labor costs. Due to construction timelines and the continued increase in construction costs, we are requesting an Emergency and Waiver for this legislation.
