### 1. Overview: Economic Development Strategy

Blackford gave an overview of the recently adopted Economic Development Strategy; said it was last updated in 2007; some portions of that plan were now outdated and the document was no longer a resource that was effective; in July 2014 a process for the request for proposal was initiated; there are 7 sections of the Strategy; first, looked at the make-up of the area compared to similar communities in Ohio; compared education and welfare and manufacturing with other comparable communities; in education and healthcare, Gahanna had above the national average and we are growing faster than the national average; manufacturing jobs show to be a growing industry; we have an effective market area, which includes Easton; there is about a significant amount of square footage in vacant space to be used for offices; also reviewed different community stakeholders and had a SWOT (strengths, weaknesses, opportunities, and threats) analysis; also have economic development strategies; said Gahanna is in a pretty good spot; have been named in the top five best hometowns to live in; Gahanna ranks in the top 50 in Ohio in number of businesses per 100 people; said there were different categories in the strategies to include entrepreneurship, marketing, global investment, and others; the Strategy pointed out priority development areas; said priority number one is West Gahanna; there are development incentives for that area; target site 1a is the area of Agler and Imperial Drive; if the City chooses to do roadway improvements the roadway would be relocated through Royal Plaza; would like to see the redevelopment occur and divide up the big box building that was developed years ago; there are no dollars currently for this project; part of the passage of this document was approved; a committee to engage citizens was created by City Council; last, we

have implementation; a table states when the project should occur and by whom; some of them are not City-initiated; the document is on the City's website under the Planning and Development webpage; also available on the CIC's website; there is a lot to the document; happy to answer any questions the Commission may have.
