I. CORRESPONDENCE AND ACTIONS

Planning Commission Members discussed the Charter Review proposed changes. The Commission had no concerns on the red line version and no one from Planning Commission needs to go to the Charter Review Public input meeting on May 18, 2021.

Wester asked what is the role of the Planning Commission, in reading Charter Review; advise Council in the preparation of; that is only part of it. Recently the School Board voted to approve funding the for a new High School. Do we have any input into it what it should look like? What is the City thinking? Should this Planning Commission be looking forward to some of it. Eventually Mill Street will come before the Commission. Wester offered a challenge to the Commission, drive south on Hamilton Road and go under the underpass and look at the road, the median, the new property there then turn around and head into Gahanna. Go up to Carpenter Road and Mill St, how can we improve the intersections heading into Gahanna. Is the Planning Commission pro-active, re-active or an afterthought? How does this Commission advise the City, is it part of the Commissions role?

Greenberg shared that when he first started on the Commission, he thought it would be more pro-active. Greenberg believes that in some respects the Commission is somewhat more re-active to what is presented.

J. POLL MEMBERS FOR COMMENT

Shapaka agreed, is the Commission pro-active or re-active. Identifying certain areas in Gahanna as you drive around, the entrances into Gahanna should be more pronounced. Is this part of the new Zoning Code; are they going to be the decision makers and the Commission is left as the finishers instead of originating the idea. Maybe the

Commission should take it upon themselves and present something to the City taking a more pro-active approach. Shapaka would like to be more pro-active.

Tamarkin agreed that the Commission should be more pro-active and maybe the re-writing of the Zoning Code gives this Commission the opportunity. Tamarkin agrees that coming into most of Gahanna has no identity.

Hicks asked the Commission to be mindful of what their role is. If the Commission wants to provide input on the re-writing of the Zoning Code, he feels it would be appropriate; but there are other groups that are responsible for more of the pro-active vision of the City. The Land Use Plan had a lot of community involvement and now that it is in place it is our duty to consider that when applications come before the Commission. Hicks is not comfortable with an application coming before the Commission that meets City Code and intent and purpose then putting his own thoughts on it. Hicks feels the Commission is a re-active body because we interpret and give opinions on applications as it pertains to City Code. There are other opportunities to participate in what the vision and use of areas should look like. He would caution the Commission not to confuse the roles.

Suriano stated that he sees the Commission as a judicial body, not a legislative body, nor an executive body, who evaluates adherence to appropriateness to City Code. It is the Commissions fundamental role for the City. A pro-active role is exciting but Suriano feels it is not the role of this Commission.

Greenberg stated that new Commission members should be given an orientation on the roles, responsibilities and City Code and the plan so they understand the roles of the Commission.
