i. Chapter 913

Ferrell brought forward changes to Chapter 913 that were approved by this Board on May 12, 2021, along with new changes requested, document attached.

Recommended changes included the following:

913.03 City and Landscape Board Rights

B- Addition of the verbiage "right of way permit must be obtained before any work may take place in the right of way", while this is not an operational change, it does need defined in this Chapter.

913.06 Landscaping for Accessory Buildings

Reviewed by planning director Blackford, it was identified that 913.06 is also in 913.11, Ferrell requests that 913.06 be stricken entirely and reflected as deleted.

913.07 Landscape Materials, Spacing and Location

Ferrell advised that this has been operationally updated for years, but the chapter needs changed to reflect the current operational workflow. The Landscape Board does not approve landscaping for architects or designs, that goes directly through planning commission.

City Forester Predieri was asked to discuss the following changes:

913.10 Street Tree Planting Requirements

E. 5- Strike stipulation of three (3) different species per street. With that requirement the City is more likely to lose trees along an entire street at once. If the City can diversify their tree species, it can create a healthier urban forest with more opportunity to have longevity in the future.

E. 7- Strike maximum spacing requirement because it doesn't make sense in certain area as trees are already planted with inconsistent spacing. Tree should be planted where they make sense.

E. 8- Strike the Street Tree Landscape Plan as it does not exist.

913.99 Penalty

A. City would like to improve the intent by adding "without permission from the City of Gahanna" to this section as well as reduce the minimum diameter from two and one-half inches to one and one-half inch.
