WHEREAS, the inspection services awarded by ORD-0104-2002 have exceeded the contract amount on the Havens Corners and Helmbright Intersection Improvement, Imp. No. 794; and

WHEREAS, funds are needed to cover the increased scope of services for this inspection contract; and

WHEREAS, it is necessary to provide this inspection service in a timely fashion, all for the preservation of the public peace, health, safety and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into amended contract with Evans, Mechwart, Hambleton & Tilton, Inc., 170 Mill Street, Gahanna, Ohio 43230, for Inspection Services for the Havens Corners/Helmbright Intersection, Imp. #794.

Section 2. That funding in the amount of THREE THOUSAND DOLLARS (\$3,000) is hereby supplementally appropriated from the unencumbered, unappropriated balance in the General Fund, to Account No. 101.145.5541, Capital Projects, Streets, to cover the herein costs.

Section 3. That ORD-0001-2003, passed January 2, 2003, is hereby amended to reflect this supplemental appropriation.
