WHEREAS, the City has created the position of GIS Manager and wishes to proceed with the hiring of an individual for that position; and

WHEREAS, after a long search in the tight job market in the Franklin County area it is the recommendation of the Administration to hire an individual at more than the bottom of the range; and

WHEREAS, it is imperative to get a person on board as quickly as possible to provide a point of contact for all mapping related processes, and all for the preservation of the public peace, health, safety and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That Article II, Pay Ranges, of ORD-0287-2000, passed December 18, 2000, as amended, is hereby amended as shown in EXHIBIT A, and made a part herein.

Section 2. That existing Article II, Pay Ranges, of ORD-0287-2000 is repealed as of the effective date of this ordinance.

Section 3. That, for the reasons set forth in the preamble hereinabove, this ordinance is declared emergency
