WHEREAS, bids were opened on April 7, 2000, pursuant to Council authorization, and the best, responsible, and responsive bidder has been recommended by the City Engineer; and

WHEREAS, it is desirable to proceed with this contract at the earliest possible date due to the current construction season, all for the preservation of the public peace, health, safety, and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Director of Public Service is authorized to award and the Mayor authorized to enter into contract with AMERICAN PAVEMENTS, INC., 7475 Montgomery Road, Plain City, Ohio 43064, for the Crack Seal Program, Improvement No. 748, in accordance with bid and city specifications.

Section 2. That to cover the herein costs, funding in the amount of EIGHTY THREE THOUSAND SIX HUNDRED EIGHTY FIVE DOLLARS (\$83,685) was set aside to Account No. 220.330.5547, Streets, Paving, in the 2000 Appropriations.

Section 3. That, for the reasons set forth in the preamble herein above, this ordinance is declared emergency legislation and shall be in full force and effect immediately upon passage by this Council and approval by the Mayor.
