WHEREAS, letter quote was received from Terra Surveying for replacement and relocation of property corners lost during the reconstruction of Taylor Road and the City Engineer has recommended we proceed; and

WHEREAS, it is desirable to proceed with this contract at the earliest possible date, due to the pending construction season, all for the preservation of the public peace, health, safety and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into agreement with Terra Surveying Services Co., 238 Academy Woods Drive, Gahanna OH 43230, for the replacement and relocation of property corners lost during the reconstruction of Taylor Road.

Section 2. That the sum of SIXTEEN THOUSAND FIVE HUNDRED DOLLARS (\$16,500) is hereby supplementally appropriated from the unappropriated, unencumbered balance of the General Fund to Account No. 101.145.5541, Capital Projects, Streets, to cover the herein costs.

Section 3. That, for the reasons set forth in the preamble herein above, this ordinance is declared emergency legislation and shall be in full force and effect immediately upon passage by this Council and approval by the Mayor.
