TO AUTHORIZE THE MAYOR TO ENTER INTO NEGOTIATED LABOR AGREEMENT TITLED "AGREEMENT BETWEEN OHIO PATROLMEN'S BENEVOLENT ASSOCIATION DISPATCHER UNIT AND CITY OF GAHANNA, OHIO, JANUARY 1, 2002 - DECEMBER 31, 2004"; TO REPEAL ORD-0138-2001; AND TO DECLARE AN EMERGENCY.

WHEREAS, Legal Counsel for the City, City Administrative Designees, and the Ohio Patrolmen's Benevolent Association Dispatcher Unit, have negotiated the pay and benefit package for the Dispatcher Unit of the Gahanna Police Department, and have made recommendation to this Council; and

WHEREAS, it is desirable to approve such negotiated Contract at the earliest possible date for employee morale, continued protection for the community, all for the preservation of the public peace, health, safety, and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into negotiated Labor Agreement, "CONTRACT BETWEEN OHIO PATROLMEN'S BENEVOLENT ASSOCIATION DISPATCHER UNIT AND CITY OF GAHANNA, OHIO, JANUARY 1, 2002 - DECEMBER 31, 2004, said Agreement attached to this ordinance as EXHIBIT A.

Section 2. That the pay and benefits of this Agreement shall be retroactive to January 1, 2002.

Section 3. That ORD-0138-2001, passed August 6, 2001, and any ordinances or parts of ordinances in conflict herewith, are hereby repealed.

Section 4. That, for the reasons set forth in the preamble herein above, this ordinance is declared emergency
