AN ORDINANCE AUTHORIZING SUPPLEMENTAL APPROPRIATIONS AND WAIVER OF SECOND READING - Traffic Signal Cabinet at US-62 and Olde Ridenour Road

**WHEREAS**, an emergency repair and replacement of the traffic cabinet at US-62 and Olde Ridenour Road is immediately necessary; and

**WHEREAS**, the costs of this repair and replacement exceed the Department of Public Service & Engineering yearly repair budget; and

**WHEREAS**, initial estimates for the repair and replacement are around \$83,000; and

**WHEREAS**, the Department of Public Service & Engineering requests supplemental appropriations from the Streets Fund in the amount of \$90,000 to ensure funds are available to perform the work; and

**WHEREAS**, the Mayor recommends waiver of second reading so that immediate action can occur to hire a contractor to replace the cabinet, components, and fiber lateral to preserve the community's health, safety, and welfare.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA,  
COUNTY OF FRANKLIN, STATE OF OHIO:**

**Section 1.** That funding in the amount of ninety thousand dollars (\$90,000) is hereby supplementally appropriated from the unappropriated unencumbered Streets Fund 2200 as follows:

*220.11.000.5205 Contract Services: \$90,000*

**Section 2.** That the second reading is hereby waived.

**Section 3.** That this Ordinance shall be in full force and effect after passage by Council and on date of signature of approval by the Mayor.
