WHEREAS, the Director of Emergency Management has recommended the City put a fence around our water tower for security purposes; and

WHEREAS, the City Engineer has obtained letterhead quotes and has recommended we proceed with the lowest bidder; and

WHEREAS, it is imperative to move forward with this project all for the preservation of the public peace, health, safety and welfare:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into Contract with CARSON FENCE, 2128 Britians Lane, Columbus, Ohio 43224 for construction of a fence around the water tower.

Section 2. That funding in the amount of SEVEN THOUSAND EIGHT HUNDRED SEVENTY TWO DOLLARS (\$7,872) is hereby supplementally appropriated from the unencumbered, unappropriated balance of the WSCI Fund, to Account No. 652.351.5596, Miscellaneous Water Improvements, to cover the herein costs.

Section 3. That ORD-0001-2002, passed January 2, 2002 is hereby amended to reflect this supplemental appropriation.

Section 4. That, for the reasons set forth in the preamble herein above, this ordinance is declared emergency
