WHEREAS, City Council and the administration, after careful study and review have determined that they will operate the Hunter's Ridge Pool this year; and

WHEREAS, in order to track expenses it is necessary and appropriate to set up separate accounts for the pool operation;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That ONE HUNDRED THIRTY THOUSAND DOLLARS (\$130,000) is hereby supplementally appropriated from the unappropriated, unencumbered balance in the General Fund to the following accounts:
