WHEREAS, the Police Department have received proposal for upgrade of the Crisis/Hostage Negotiating Telephone/Video System and Chief Murphy is recommending that we proceed with this upgrade from Professional Safety, Inc., a division of Enforcement Technology Group Inc;

WHEREAS, it is imperative to move forward with this immediately all for the preservation of the public peace, health, safety and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into agreement with Professional Safety Inc., 400 North Broadway, Milwaukee, WI 53202, for the upgrade of the Crisis/Hostage Negotiating Telephone/Video System, in accordance with proposal attached hereto as EXHIBIT A, and in accordance with all City Specifications.

Section 2. That the amount of FOUR THOUSAND DOLLARS (\$4,000) is hereby supplementally appropriated from the unappropriated, unencumbered Balance of Account No. 235.211.5411, Federal Law Enforcement Trust Fund, to cover the herein costs.

Section 3. That ORD-0001-2000 passed January 3, 2000 is hereby amended to reflect this supplemental appropriation.
