WHEREAS, the funds are currently unappropriated and unencumbered; and

**WHEREAS**, the Department of Public Service requests supplemental appropriations from the Water Fund for various materials and supplies needs.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

**Section 1.** That funding in the amount of fifteen thousand one hundred nineteen dollars (\$15,119) is hereby supplementally appropriated from the unappropriated unencumbered Water Fund 6511 as follows:

651.11.000.5300 Materials and Supplies: \$15,119

**Section 2.** That this Ordinance shall be in full force and effect after passage by Council and on date of signature of approval by the Mayor.
