AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO CONTRACT WITH STRAWSER PAVING COMPANY, INC., FOR THE 2021 RESIDENTIAL STREET PROGRAM ST-1075.

WHEREAS, bids were opened and reviewed on March 5, 2021, pursuant to Council authorization, and the best, responsible, and responsive bidder has been recommended by the City Engineer for construction services of the 2021 Residential Street Program; and

WHEREAS, a total of four (4) bids were received with the lowest most responsive and responsible bidder being Strawser Paving Company, Inc.; and

WHEREAS, this year's residential street program consists of asphalt resurfacing, crack sealing, street rebuilds, striping, and striping improvements,

NOW, THEREFORE, BE IT ORDAINED, BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into contract with Strawser Paving Company, Inc., 1595 Frank Road, Columbus, Ohio, 43223, for the 2021 Residential Street Program.

Section 2. That funding in the amount of Four million five hundred eighty-six thousand seventy five dollars and sixteen cents (\$4,586,075.16) was set aside in 2021 appropriations to cover the herein costs.

Section 3. That this Ordinance shall be in full force and effect immediately upon passage by this
