WHEREAS, lease agreement approved by Ordinance 970150, passed on July 8, 1997 provides an option for the renewal of the lease for 5 years at the same terms; and

WHEREAS, the Gahanna Jefferson Local School District has notified the City in writing that they wish to exercise this option; and

WHEREAS, the current lease expires on October 9, 2002 and provides for a one time 5 year extension; and

WHEREAS, it is imperative to move forward with this exercise of option of lease agreement at the earliest possible date for the orderly flow of business at the onset of the school year, all for the preservation of the public peace, health, safety, and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into Lease Agreement as exercised under option provision in current lease with GAHANNA JEFFERSON LOCAL SCHOOL DISTRICT, said agreement attached hereto as Exhibit A.

Section 2. That, for the reasons set forth in the preamble hereinabove, this ordinance is declared emergency legislation and shall be in full force and effect after passage by this Council and on date of signature approval by the
