WHEREAS, Planning Commission has recommended to Council for adoption the Olde Gahanna Design Guidelines; and

WHEREAS, in conjunction with the adoption of said plan several code changes should also be implemented; and

WHEREAS, Planning Commission recommended these changes on March 27, 2002; and

WHEREAS, Council held Public Hearing on May 6, 2002, said meeting held pursuant to notice and according to law;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That Sections 1150.09, New Construction; 1150.10, Restrictions; 1150.11, Design Recommendations; 1150.12, Signs, of Chapter 1150, Olde Gahanna Downtown District, is hereby amended as set forth in EXHIBIT A, attached hereto and made a part herein.

Section 2. That existing Sections 1150.09, New Construction; 1150.10, Restrictions; 1150.11 Design Recommendations; 1150.12, Signs, of Chapter 1150, Olde Gahanna Downtown District, or any ordinances or parts of ordinances in conflict herewith, are hereby repealed.
