### **AN ORDINANCE AUTHORIZING SUPPLEMENTAL APPROPRIATIONS AND WAIVER OF SECOND READING - General Fund Police Overtime, Workers Comp, Medicare, and Police Pension Fund**

**WHEREAS**, the Council has authorized the Mayor to enter into a Bargaining Unit Agreement with the Fraternal Order of Police, Capital City Lodge No. 9 for the period beginning January 1, 2022, through December 31, 2024; and,

**WHEREAS**, the approval of the contract terms of the Bargaining Unit Agreement were retroactive to January 1, 2022, and allow members to receive back wages; and

**WHEREAS**, the Department of Administrative Services and Division of Police request a supplemental appropriation from the unencumbered, unappropriated fund balance of the General Fund in the amount of \$102,950 and the Police Pension Fund in the amount of \$19,500 to implement the new contract; and

**WHEREAS**, the administration has requested a waiver of second reading in order to fulfill the new contract terms.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA,  
COUNTY OF FRANKLIN, STATE OF OHIO:**

**Section 1.** That the Council authorizes fiscal year 2022 supplemental appropriations for the following fund accounts:

101.10.110.5115 Police Overtime: \$100,000

101.10.110.5140 Police Workers Comp: \$1,500

101.10.110.5145 Police Medicare: \$1,450

510.06.000.5130 Police Pension: \$19,500

**Section 2.** That the second reading is hereby waived.

**Section 3.** That this Ordinance shall be in full force and effect immediately upon final passage by this Council and on date of signature of approval by the Mayor.
