WHEREAS, to meet ADA compliance for wheelchair ramps the City needs updated standard drawings, a transition plan and an inventory; and

WHEREAS, it is imperative to proceed with the updating of these wheel chair ramps as soon as possible, all for the preservation of the public peace, health, safety and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. To authorize the Mayor to enter into contract with Evans, Mechwart, Hambleton & Tilton, Inc., 170 Mill Street, Gahanna, Ohio 43230, for ADA compliant standard drawings and transition plan for wheelchair ramps, in accordance with proposal, attached as EXHIBIT A.

Section 2. That funding in the amount of TEN THOUSAND DOLLARS (\$10,000) is hereby supplementally appropriated from the unappropriated, unencumbered balance in the General Fund, to Account No. 101.145.5533, Capital Projects, Engineering, to cover the herein costs.

Section 3. That ORD-0001-2002, passed January 2, 2002, is hereby amended to reflect this supplemental appropriation.

Section 4. That, for the reasons set forth in the preamble herein above, this ordinance is declared emergency
