TO ESTABLISH THE RATES OF PAY AND BENEFITS FOR UNCLASSIFIED PERSONNEL OF THE CITY OF GAHANNA FOR THE PERIOD JANUARY 1, 2016 THROUGH DECEMBER 31, 2016; TO REPEAL ORD-0182-2014; AND TO DECLARE AN EMERGENCY.

WHEREAS, ORD-0182-2014, passed December 15, 2014, provided the salary and benefit package for the unclassified employees of the City of Gahanna through December 31, 2015; and

WHEREAS, it is deemed appropriate by this Council for employee morale and continuity of City business to proceed with new legislation for salary and benefit provisions to be effective January 1, 2016, all for the preservation of the public peace, property, health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That where not in conflict with the Charter, Ordinances, or lawfully promulgated rules and regulations of the City of Gahanna, the Master Salary Ordinance for full-time unclassified personnel of the City of Gahanna, is hereby enacted as noted in EXHIBIT A attached hereto.

Section 2. That the pay and benefits of this Ordinance shall be effective January 1, 2016, except as otherwise noted.

Section 3. That ORD-0182-2014 or any Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 4. That, for the reasons set forth in the preamble hereinabove, this Ordinance is declared
