TO ESTABLISH THE RATES OF PAY AND BENEFITS FOR COMMAND OFFICERS OF THE CITY OF GAHANNA POLICE DEPARTMENT FOR THE PERIOD JANUARY 1, 2002 THROUGH DECEMBER 31, 2002; TO REPEAL ORDINANCE NO. ORD-0187-2001; AND TO DECLARE AN EMERGENCY

WHEREAS, ORD-0187-2001, passed September 4, 2001, provided the salary and benefit package for the Chief and Deputy Chief of Police of the City of Gahanna through December 31, 2001; and

WHEREAS, ORD-0259-2001, passed December 17, 2001 amended ORD-0187-2001 until such time as labor negotiations were completed and a review by the Administration could be undertaken; and

WHEREAS, in order to effect the terms of this ordinance, it is deemed necessary and prudent to declare this legislation emergency for guaranteed continuity for the heads of our police division, all for the preservation of the public peace, health, safety, and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, STATE OF OHIO:

Section 1. That where not in conflict with the Charter, Ordinances, or lawfully promulgated rules and regulations of the City of Gahanna, the Master Salary Ordinance for Command Officers (Chief and Deputy Chief of Police) of the City of Gahanna, is hereby enacted as noted in EXHIBIT A attached hereto.

Section 2. That the pay and benefits of this ordinance shall be effective January 1, 2002.

Section 3. That ORD-0187-2001 or any ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. That, for the reasons set forth in the preamble herein above, this ordinance is declared emergency
