**AN ORDINANCE TO AUTHORIZE THE PURCHASE OF PORTABLE RADIOS AND FIRMWARE UPGRADES FROM MOTOROLA SOLUTIONS PURSUANT TO STATE TERM CONTRACT**

**WHEREAS**, the City’s portable radio assets (Police, Parks, and Service) are within a 7-8-year lifecycle management plan; and

**WHEREAS**, the current inventory of portable radio assets is between 8-11 years old and have exceeded or are approaching end of life; and

**WHEREAS**, the State of Ohio’s Multi-Agency Radio Communications System (MARCS), of which the City is a subscriber, has mandated additional firmware requirements within each radio by 2025; and

**WHEREAS**, the Department of Public Safety recommends expenditure of \$557,284 with Motorola Solutions in accordance with the terms of Ohio State Term Schedule Contract (Index: STS073; Contract Number: 573077-0); and

**WHEREAS**, funding for this project is within the 2023 budget approved for the Division and requires

no supplemental funding.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA,  
COUNTY OF FRANKLIN, STATE OF OHIO:**

**Section 1.** That the Council authorizes the expenditure of \$557,284 with Motorola Solutions, 13108 Collections Center Dr, Chicago, IL 60693 in accordance with the terms of the Ohio State Term Schedule Contract (Index: STS073; Contract Number: 573077-0) for the replacement and upgrade of the City's portable radio inventory pursuant to the quotes attached hereto as EXHIBIT A and EXHIBIT B and made a part herein.

**Section 2.** That funding is available and has been set aside in the 2023 Budget Appropriations to cover the herein costs.

**Section 3.** That this Ordinance shall be in full force and effect upon passage by this Council and 30 days after date of signature of approval by the Mayor.
