TO AUTHORIZE THE MAYOR TO ENTER INTO THE STEELWORKERS HEALTH AND WELFARE PLAN PARTICIPATION AGREEMENT EFFECTIVE JANUARY 1, 2017, TO PROVIDE MEDICAL, PRESCRIPTION, DENTAL, AND VISION COVERAGE FOR EMPLOYEES UNDER THE STEELWORKERS BARGAINING UNIT AGREEMENT; AND TO DECLARE AN EMERGENCY.

WHEREAS, under the terms of the existing labor agreement, a cost comparison was done regarding employee group medical insurance; and

WHEREAS, the rates were just provided to the City by the Steelworkers Health and Welfare Fund; and

WHEREAS, it is critical for the orderly flow of business to allow this agreement to be entered into as soon as possible, and all for the preservation of the public peace, property, health, safety, and welfare.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into "Steelworkers Health and Welfare Fund Participation Agreement" as outlined in EXHIBIT A, attached hereto and made a part herein; to be effective January 1, 2017, through December 31, 2017.
