TO AUTHORIZE THE MAYOR TO ENTER INTO CONTRACT WITH OHM ADVISORS TO CREATE A COMPREHENSIVE LAND USE PLAN.

WHEREAS, the Go Forward Gahanna Strategic Result 1.4: Updated and Accessible Development Plans identified the need for the City to update and unify our existing land use and area plans and in response, the Planning & Development Department issued a request for proposal (RFP) for a comprehensive land use plan; and

WHEREAS, OHM Advisors was selected with Regionomics and Aimpoint as sub-consultants at an anticipated cost of \$90,000; and

WHEREAS, funding for this project were previously appropriated for.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into Contract with OHM Advisors to create a comprehensive land use plan; said Contract attached hereto as EXHIBIT A, and made a part herein.

Section 2. That funding in the amount of NINETY THOUSAND DOLLARS (\$90,000) has been appropriated in Account No. 101.343.5253 in prior year encumbrances.
